Minimum income payments for investors using super money

If you are an individual using super money to invest, then under superannuation laws we are required to pay you a minimum annual amount of income. The minimum annual payment requirements are based on a percentage of your Account Balance at commencement in the first financial year, or the Asset Value at each subsequent 1 July. The percentage is age based as per the super laws, may change from time to time, and is set out below in Column A.

In determining the Free Withdrawal Amount for these policies, the Minimum Payment percentage used to calculate the Free Withdrawal Amount is the minimum payment percentage required under superannuation laws (Column A) or other amount as set out in Column B below - whichever is higher.
