

## Important information about your AGILE investment

# We are reducing your Product Fee

This notice applies to those who invested in Allianz Guaranteed Income for Life (AGILE) prior to 19 January 2026.

We have recently undertaken a review of our Product Fees and this notice informs of a change to the Product Fee.

With effect from 23 February 2026 (**Effective Date**) we are reducing the Product Fee to 0.30% per annum for our existing Allianz Guaranteed Income for Life (**AGILE**) investors who have invested in AGILE under the Product Disclosure Statement dated 24 November 2023.

### How will this change take effect?

#### Until 23 February 2026

The Product Fee will continue to be charged at the rate of **0.80% per annum**, calculated and accrued daily on your investment.

#### On or after 23 February 2026

From this date, the Product Fee on your AGILE investment will be changed to **0.30% per annum** and will be calculated and accrued daily at this new rate.

**For example:** for an existing AGILE investor with an opening Investment Value of \$200,000, this would result in a \$1,000 reduction in Product Fee on a full-year basis, all else being equal.

Because product fees are deducted annually on your Anniversary Date, this means that the Product Fee deducted on your next Anniversary Date after 23 February 2026 will be a pro-rated amount charged at a rate of 0.80% per annum for each day up until but not including 23 February 2026, and 0.30% per annum each day thereafter.

All other terms and conditions in relation to your AGILE investment will continue to apply.
